

Appendix 1: Sub Processors of Ubeeqo

Here is a list of the main sub-processors of Ubeeqo to whom users' personal data may be disclosed. These data recipients are categorised below according to the sub-contractor and the purpose of the data processing. Kindly note that this list may be amended from time to time to provide you with a better and more accurate view of Ubeeqo's sub-processors at any given time.

1) Analytics

The services contained in this section enable Ubeeqo to monitor and analyse web traffic and can be used to keep track of user's behaviour.

2) Managing contacts and sending messages

This type of service makes it possible to manage a database of email contacts, phone contacts or any other contact information to communicate with the user. These services may also collect data concerning the date and time when the message was viewed by the user, as well as when the user interacted with it, such as by clicking on links included in the message.

3) Registration and authentication

By registering or authenticating, users allow UbeeQo to identify them and give them access to dedicated services. Depending on what is described below, third parties may provide registration and authentication services. In this case, UbeeQo will be able to access some data, stored by these third-party services, for registration or identification purposes.

4) Web hosting and backend infrastructure

This type of service has the purpose of hosting data and files that enable Ubeeqo's platform/software to run and be distributed as well as to provide a ready-made infrastructure to run specific features or parts of Ubeeqo. Some of these services work through geographically distributed servers, making it difficult to determine the actual location where the personal data is stored.

5) Handling payments

Payment processing services enable Ubeeqo to process payments by credit card, bank transfer or other means. To ensure greater security, Ubeeqo shares only the information necessary to execute the transaction with the financial intermediaries handling the transaction. Some of these services may also enable the sending of timed messages to the user, such as emails containing invoices or notifications concerning the payment.

6) User database management and lead generation services

This type of service allows Ubeeqo to build user profiles by starting from an email address, a personal name, or other information that the user provides to Ubeeqo, as well as to track user activities through analytics features. This personal data may also be matched with publicly available information about the user (such as social networks' profiles) and used to build private profiles that the Owner can display and use for improving Ubeeqo. Some of these services may also enable the sending of timed messages to the user, such as emails based on specific actions performed on Ubeeqo.
